Dear Shareholders,

I am delighted to present the slate of candidates for Moscow Exchange's April 2016-April 2017 Supervisory Board that have been recommended by the current Board's Nomination and Remuneration Committee. The introduction of candidates ahead of the AGM was well-received by shareholders last year, so we decided to continue that practice with the aim of ensuring the highest standards of transparency.

At the 2015 AGM, shareholders voted to reduce the size of the Supervisory Board from 15 to 12 members. The new 12-member Board will be elected at the 2016 AGM. The Nomination and Remuneration Committee has assembled an excellent slate of candidates that ensures continuity while also representing a strong mix of competencies and backgrounds. Five of the 12 candidates are independent (well above our requirement of one third independent directors) and 11 out of 12 nominees are current Board members.

When forming committees, we expect the Audit Committee and the Nomination and Remuneration Committee will include exclusively independent directors, while at least one additional committee will also be chaired by an independent director.

Duncan Paterson is nominated for membership on the Board for the first time. Mr Peterson has a wide expertise in corporate finance and financial services, risk management and related IT-services. He will bring additional value in the areas of audit, risk management, corporate governance, IT and strategic planning. Since 2000, Mr. Paterson has been a sought-after consultant in the financial services industry, with a focus on developing and running consortia for the global investment banks. He is also non-executive Chairman of GH Financials Limited, a company that provides order-routing, clearing and settlement services to the world's derivatives markets. Mr. Paterson started his career with PwC in London, and subsequently CFO of the debt division of an international US bank, which was the leader in the introduction of financial "swaps" products and COO of the fund management arm of a large UK bank, which was a pioneer of quantitative investment strategies. He was later CEO of Wilco International, a fast growing international financial software house that developed the first client-server based system for international settlement of financial trades, which became the de facto global standard product of its generation.

Over the course of 2015 the current Board has been actively involved in the affairs of Moscow Exchange. Key steps taken by the Board have included the approval of the Company's new strategy, adoption of a revised dividend policy, and the creation of a corporate governance code. I am confident the recommended Board members will contribute to the ongoing success of the Moscow Exchange.

I wholeheartedly recommend shareholders support the proposed slate of candidates, in particular the independent candidates.

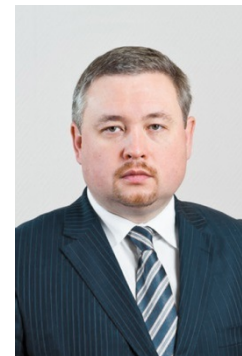

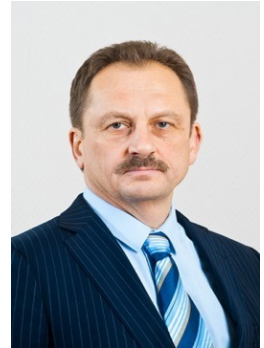
