Additional terms of market makers incentives

Market maker Fee = MIN (Maker Volume Traded * (Exchange Fee Rate + **Premium Rate**) * R_i ; 25 000 RUB)

where **Premium Rate** = 0.00004

Maker Volume Traded determined by market makers trades on order not less than Minimum Order Size.
