



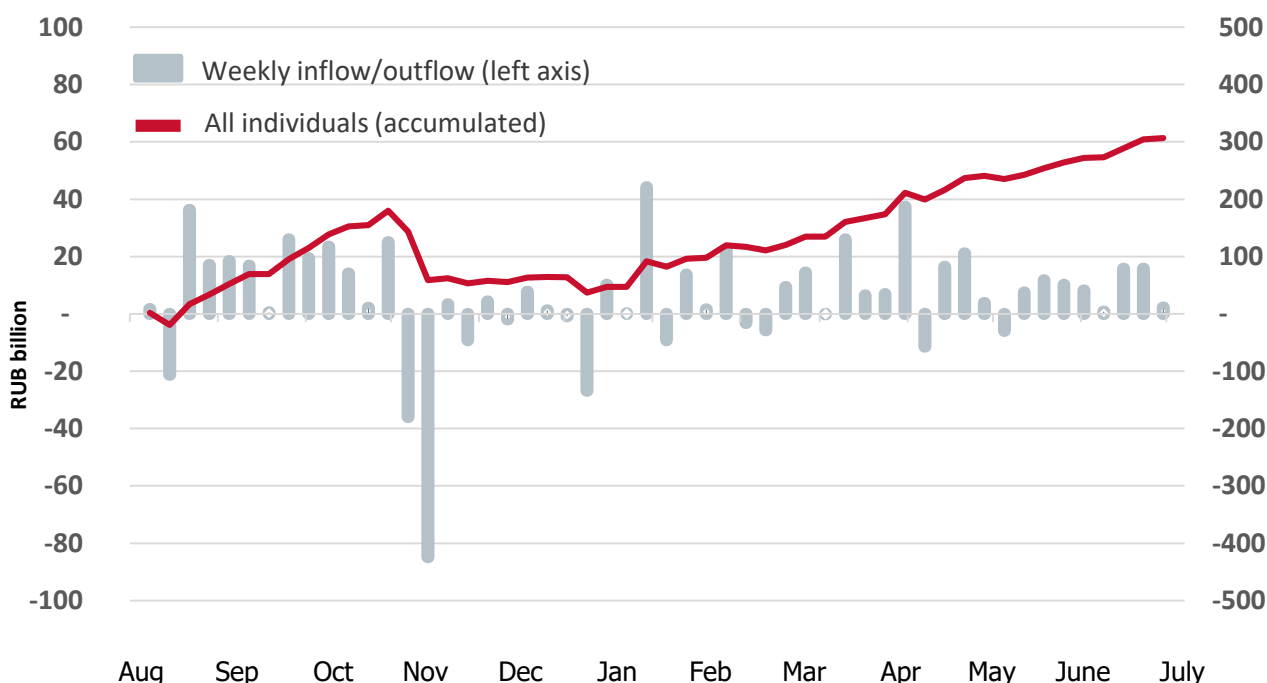

- The most market inflow was seen in the week of 19 to 23 July totaling in **₽16 billion**.
- Total inflow increased by **₽307 billion** during the last 12 months.
