

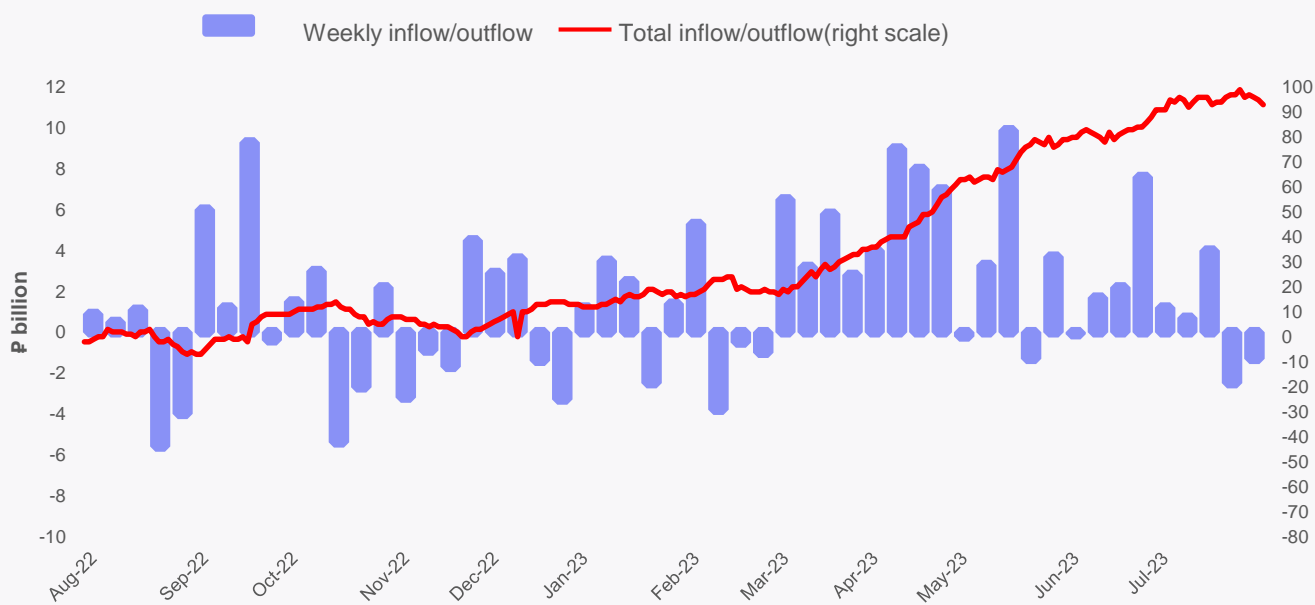
# EQUITY MARKET REVIEW

- In July, retail investors bought Russian shares listed on MOEX to the amount of **₽ 2,16 billion\***.
- The most market inflow was seen in the week of 10 to 17 of July totaling in **₽4 billion**.
