




EQUITY MARKET REVIEW

- In October, retail investors bought Russian shares listed on MOEX to the amount of \$\mathbb{P}\$ 2,24 billion*.
- The most market inflow was seen in the week of 23 to 27 of October totaling in P3,6 billion.
